

LEARN ABOUT TRADITIONAL GREENWOOD WOODWORKING FROM PETER FOLLANSBEE

Since 1980 Peter Follansbee has researched, written about, and practiced traditional green woodworking exclusively using hand-tools. For much of this period, he collaborated with John/Jennie Alexander who introduced him to green woodworking. For 20 years he worked as the joiner at the living history *Plimoth Plantation* in Plymouth, Massachusetts. The Plantation now forms part of Plimoth Pautuxet Museums and replicates the original 17th century settlement of Plymouth Colony established by English settlers known to many of us as the "Pilgrims."

For some years Follansbee has concentrated on 17th – century joinery, mostly in oak, to produce boxes, chests, chairs, and tables. You can access his work at:


